## 4-Oculus Tempore Oct 17 Summary

## Detail

- Having survived the battle at the "Shoppes"
  - We all meet at the Iron Maiden
  - Hans stables Chewie Wildfire on board with the other animals.
  - **Long Rest**
    - During which Talon learns about the Iron Maiden's engineering.
    - Hans learns basic navigation (not time travel).
    - Kryssle learns a little about loading the cannons; but cannot fire them.
  - We go see Falak so Luna and Iraa can learn about their recent past.

  - When we are alone, they panic, and want us to leave immediately, we are in danger.
  - Dawnis leaves and comes back with eleven year old Kryssle Wynderfall
  - She is a necromancer shell (dead on the outside) but her sole is trapped.
  - She acts like she had sever mental issues.
  - Billiam Wynderfall explains that just prior to her funeral Dolfus shows up and takes the body away.
  - This was three days after we left them at their estate.
  - He brings her back in this condition and tell the Wynderfalls that if they say or do anything to defy him, Kryssle will instantly die!
  - The "dead" Kryssle is returned to her room.
  - We are told that any information about The Queen might be had from Rook her former captain of the guards.

- We find **Rook** in his bar downtown
  - The Captain of the Guard was engaged to **Francesta**.
  - The ex-captain of the guard was forced from his position in disgrace.
  - There was an attempted assignation of **The Queen** that was kept secret.
  - The attack failed, but **Dolfus** was present.
  - And he has gained a great deal of influence over the royal family.
  - He is now engaged to **Francesta** and **Rook** was charged with several crimes. He was exonerated, but disgraced.
  - **Rook** does not trust **Dolfus** and said that **Francesta** was not the same.
  - She does not look the same nor act the same. **The Queen** went into seclusion after the attack happened.
  - **Rook** thinks that **Francesta** is controlling The Queen somehow.
  - **Rook** shows a necklace he tore from the Assassin.
  - It has a crystal symbol on it that is the mark of the Proxima Assassins Guild.
